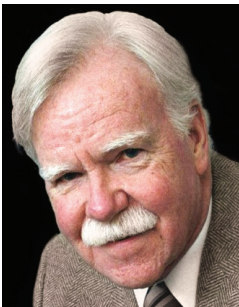




## BILL TSCHOHL

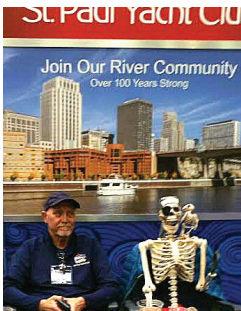
